# **DRAMA SHORT FILM FESTIVAL**

# **REGULATION 2024**

## I. Preamble

The Drama Short Film Festival 2024 is organized by the legal entity governed by public law "Cultural Organization - Drama Short Film Festival" (hereinafter the "Festival") of the Municipality of Drama, Drama, Greece (Government Gazette B '2521/2012). The Festival aims at the promotion and development of cinematographic art, the preservation of audiovisual works - short films, the promotion of cinematographic art in Greece, the cultural decentralization and the dissemination of Greek short films, as well as at the encouragement of networking and friendship between creators, filmmakers and actors worldwide.

This Regulation governs the conduct of the Short Film Festival, according to the specific provisions for each competition section, for the year 2024 and participation implies acceptance without reservation of all the terms outlined in the present regulation. For the participation to be considered valid, the necessary documents, declarations and guarantees provided herein must be submitted by the participants (hereinafter and for the sake of brevity also referred to as "participants"). The Festival reserves the right to cancel any submission or to take any appropriate action in case of violation of the terms and conditions set forth in this Regulation or in case of act or omission that disrupts the proper conduct of the Festival.

# II. Competition Sections

# 1. National Competition

## **General Principles**

- A. The 47<sup>th</sup> National Competition of the Drama Short Film Festival will take place from September 2nd to 8th, 2024.
- B. To be eligible for participation, films shall meet the following conditions:

B.a. Greek Premiere is required for the submission of films to the National Competition. Therefore, prior public performance, screening, broadcasting or rebroadcasting of the works to the public by radio and television by any means to the public in Greece or on-demand access in any way before or during the days of the Festival are not allowed. The presentation of the film shall be deemed to be public when the film becomes accessible to a circle of persons wider than the

narrow circle of the family and the immediate social circle of the author, regardless of whether the persons of this wider circle are at the same or at different locations.

- B.b. Films shall be completed within the year 2023 or 2024.
- B.c. The DCP to be screened at the Festival shall be available in one of the formats provided for in this Regulation for theatrical screening and in one of the formats provided for in this Regulation for online screening.
- B.d. The films must be of Greek production or co-production and the directors must be Greek or Cypriot.
- B.e. Each director may participate in the Festival with only one (1) film, and shall declare the type of film (documentary, fiction, animation),
- B.f. Film genres that may participate : fiction films, documentary films, animated films, experimental films.
- B.g. Films that have participated and rejected by the Preliminary Committee may not be submitted.

# 1.1. Deadline for application

The application form, the material and a digital copy of the film shall be submitted by May 15, 2024 electronically on <a href="www.filmfreeway.com">www.filmfreeway.com</a>. Any film selected for the competition may not be removed from the selection.

# 1.2. Application: Entry Procedure and Material

The applicant shall submit by May 15, 2024, the application free of charge via the platform filmfreeway.com. A non-public secure/password-protected link of the film shall be submitted with subtitles in Greek or in English.

# 1.3. Preliminary Committee

- a. Films are selected for the competition by the Preliminary Committee, appointed by the Board of the Cultural Organization upon the Artistic Director's or, (if he is prevented), his Deputy's proposal. The Preliminary Committee is chaired by Artistic Director's or his Deputy.
- b. Once the films for the competition are selected, applicants shall be informed, by any appropriate means, about the decision of the Committee. Applicants shall not disclose the decision and not make any relevant statement and/or publication on media, including social media until the official public announcement of the Festival.
- c. Films that have not been selected for the competition do not participate during the screening days of the Festival, but are included in the Film Market, as further defined

in term VI hereof, provided that the applicant has provided a relevant license at his application.

d. The Preliminary Committee may, in its sole discretion, approve one or more films submitted to the Present Competition Program, for further participation in other Programs in accordance with the provisions of this Regulation and in particular for the International Competition Short & Green, International Animation Competition Programme and for the Program – Cinematherapy Lab provided that these films meet the general principles of this and the corresponding Competition program and after the consent of the candidates has been obtained.

#### 1.4. Materials

# 1.4.a. Catalogue materials

After the selection of films, the director/producer shall submit by June 25, 2024 the following:

- a. Information related to the film: contributors, summary, director's CV and filmography in Greek and in English.
- b. If the original language of the film is not Greek, a list of dialogues of the film in Greek must also be submitted. Otherwise, the film must be subtitled in Greek.
- c. At least one (1) photograph/screenshot of the film and one (1) of the director.
- d. The declaration license and guarantees of the author and / or producer of and / or rightholder over the film, as provided in Annex I hereof, signed.

The files submitted with the application form remain in the Festival Archive, as defined in term V hereof. When submitting the application, the producer declares whether he wishes the inclusion of the film in the Film Market, as defined in term VI hereof and in accordance with the specific terms to be notified to the applicants.

# 1.4.b. Screening materials

Materials of the films for the final screening should be submitted by 5th to 20th July 2024.

The DCP for the cinematic screening and the other material described below must have been submitted or sent for reception to the offices of the Festival in Athens (Emm. Benaki 71, 10681 Athens) by 20 July 2024 and by 16.00. The following material shall be submitted:

a) Digital Cinema Package (DCP) in one of the following acceptable formats:

- -DCP subtitled in English or Greek for films in a language different than Greek.
- -Apple ProRes, subtitled in English or Greek for films in a language different than Greek.
- -H264 subtitled in English or Greek for films in a language different than Greek.
- -MPEG4, subtitled in English or Greek for films in a language different than Greek.
- b) For the online screening on the platform of the Festival are additionally required:
- -One downloadable (1) vimeo link, a film poster and a trailer
- -One (1) mp4 file of the final version of the film, subtitled in English or Greek for films in a language different than Greek, for the Film Market, as further defined in term VI hereof
- One Poster of the film in A4 format
- c) Signed statements of final technical check by the technical manager of the film and the director.

# 1.5. Awards Committee - Jury

- a) Members of the Awards Committee are appointed by the Board of the Cultural Organization upon the Artistic Director's or, (if he is prevented), his Deputy's proposal. The Awards Committee consists of at least 5 members and appoints the Chairman. The nominated members of the Awards Committee shall be experts of cinema & the arts, filmmakers of various specialties, theorists, historians, or film critics or come from the field of film education.
- b) The Award Committee shall not include a person who has contributed to the creation, production or commercial exploitation of the films competing in the Festival or who has a relationship up to the second degree with a person who has contributed to the creation, production or commercial exploitation of a film competing at the Festival.
- c) The members of the Committees are not allowed to announce their discussions and decisions, before the official announcement of the results, nor to comment on the films that compete in the Festival.
- d) The Award Committee shall meet, necessarily in the presence of a representative of the Festival (secretary) at the invitation of its chairman. Present members shall be more than absent.
- e) Decisions shall be taken in an open vote and by an absolute majority of its members.
- f) The final meeting of the Awards Committee must be adjourned no later than at 8 am of the award day. The Awards Committee shall sign and submit to the Festival a report containing the results and votes (which are not made public by the Festival) for

the awards, the names of the members who participated. The original minutes remain in the Secretariat of the Festival.

g) Any change in award or distinction after the dissolution of the meeting is not possible.

# 1.6. Awards

The following awards shall be attributed in the 46<sup>th</sup> National Competition and will be accompanied by a monetary award, provided that sponsorships are secured:

The Golden Dionysos, Silver Dionysos, Documentary, Audience and Queer awards are awarded to the Director of the film. The rest of the Awards are awarded to each artist (actor, photographer, editor etc.) It is expressly provided that awards may not be shared.

Drama International Short Film Festival is qualified by the American Academy of Motion Picture Arts and Sciences. Recipients of the festival's Golden Dionysos will be eligible for consideration in the Short Films competition of the Academy Awards® without the standard theatrical run, provided the film otherwise complies with the Academy rules. (Oscar® qualified)

# 2. International Competition

# **General Principles**

- A. The 30th International Competition of the Drama Short Film Festival will take place from September 2nd to 8th, 2024.
- B. To be eligible for participation, films shall meet the following conditions:
- B.a. Greek Premiere is required for the submission of films to the International Competition. Therefore, prior public performance, screening, broadcasting or rebroadcasting of the works to the public by radio and television by any means to the public in Greece or on-demand access in any way before or during the days of the Festival are not allowed. The presentation of the film shall be deemed to be public when the film becomes accessible to a circle of persons wider than the narrow circle of the family and the immediate social circle of the author, regardless of whether the persons of this wider circle are at the same or at different locations.
  - B.b Films shall be completed after January 1<sup>st</sup> of 2023.
  - B.c. The DCP to be screened at the Festival shall be available in one of the formats provided for in this Regulation for film screening and in one of the formats provided for in this Regulation for online screening.
  - B.d Their duration should not exceed forty minutes (40) minutes with the end credits. In exceptional cases, with a reasoned opinion of the Artistic Director and a decision of the Board, the Festival reserves the right to accept a longer film.
  - B.e Each director may participate in the Festival with only one (1) film, and shall declare the type of film (documentary, fiction, animation),
  - B.f. Film genres that may participate : fiction films, documentary films, animated films, experimental films.
  - B.g. Films that have participated and rejected by the Preliminary Committee may not be submitted.

# 2.1. Deadline for application - Application Fee

- a. The application form, the material and a digital copy of the film shall be submitted by May 8, 2024 through the website <a href="www.filmfreeway.com">www.filmfreeway.com</a>. Upon its discretion, the Festival may announce the submission of application through other platforms.
- b. Submission fee of twenty (20) euros per film submitted until the 30<sup>th</sup> of April is required. For films submitted from 1<sup>st</sup> to 8<sup>th</sup> of May, the submission fee amounts to twenty five (25) euros. Payment is due with submission. Once the digital submission is finalized, fees may not be refunded. In addition, the festival reserves the right to provide discounted or total waver codes to film or educational institutions or directors unable to pay the submission fees. Waivers are provided upon their request before the Independent Department of the Drama Short Film Festival, and relevant Administration's decision.

# 2.2. Application: Entry Procedure and Material

The application and the film in digital shall be submitted through <a href="https://www.filmfreeway.com">www.filmfreeway.com</a> or other platforms.

In case of selection the following should also be submitted:

- 1. Completed submission entry form
- 2. File for the projection
- 3. English subtitles
- 4. Film's synopsis
- 5. One still from the film
- 6. The declaration license and guarantees of the author and / or producer of and / or rightholder over the film, as provided in Annex I hereof, signed.
- 7. A photograph of the director
- 8. SRT in English
- 9. Director's CV and Filmography (international title and release year of each film).

The files submitted with the application form remain in the Festival Archive, as defined in term V hereof. When submitting the application, the producer declares whether he wishes the inclusion of the film in the Film Market, as defined in term VI hereof and in accordance with the specific terms to be notified to the applicants.

# 2.3. Preliminary Committee

- a. Films are selected for the competition by eight to twelve (8-12) members of the Preliminary Committee and the head of the Preliminary Committee who oversees their work. All members of the Committee shall be experts from the audiovisual sector. The Preliminary Committee shall be appointed by the Board of the Cultural Organization upon the Artistic Director's or, (if he is prevented), his Deputy's proposal.
- b. At least eight (8) selection committee members should be appointed for the needs of the final selection of the films submitted to the International section. They should be working in film and specialities include: directors, cinematographers, editors, actors, critics, theorists, film historians, journalists, filmmakers, etc.
- c. Once the films for the competition are selected, applicants shall be informed, by any appropriate means, about the decision of the Committee. Applicants shall not disclose the decision and not make any relevant statement and/or publication on media, including social media until the official public announcement of the Festival.
- d. The Preliminary Committee may, in its sole discretion, approve one or more films submitted to the Present Competition Program, for further participation in other Programs in accordance with the provisions of this Regulation and in particular for the International Competition Short & Green, International Animation Competition Programme and for the Program – Cinematherapy Lab provided that these films meet the general principles of this and the corresponding Competition program and after the consent of the candidates has been obtained.
- e. Films that have not been selected for the competition do not participate during the screening days of the Festival, but are included in the Film Market, as further defined in term VI hereof, provided that the applicant has provided a relevant license at his application.

The DCP for the cinematic screening and the other material described below must have been submitted or sent for reception to the offices of the Festival in Athens (Emm. Benaki 71, 10681 Athens) by 20th July 2024 by 16.00. The following material shall be submitted:

- -Apple ProRes, subtitled in English.
- -H264 subtitled in English.
- -MPEG4, subtitled in English.
- b) For the online screening on the platform of the Festival are additionally required:
- -One (1) mp4 file of the final version of the film, subtitled in English, for the Film Market, as further defined in term VI hereof.
- One poster on the film in A4 format.
- c) Signed statements of final technical check by the technical manager of the film and the director.

# 2.5. Awards Committee – Jury

- a) Members of the Awards Committee are appointed by the Board of the Cultural Organization upon the Artistic Director's or, (if he is prevented), his Deputy's proposal. The Awards Committee consists of at least 3 members and appoints the Chairman. The nominated members of the Awards Committee shall be experts of cinema & the arts, filmmakers of various specialties, theorists, historians or film critics or come from the field of film education.
- b) The Award Committee shall not include a person who has contributed to the creation, production or commercial exploitation of the films competing in the Festival or who has a relationship up to the second degree with a person who has contributed to the creation, production or commercial exploitation of a film competing at the Festival.
- c) The members of the Committees are not allowed to announce their discussions and decisions, before the official announcement of the results, nor to comment on the films that compete in the Festival.
- d) The Award Committee shall meet, necessarily in the presence of a representative of the Festival (secretary) at the invitation of its chairman. Present members shall be more than absent.
- e) Decisions shall be taken in an open vote and by an absolute majority of its members.
- f) The final meeting of the Awards Committee must be adjourned no later than at 8 am of the award day. The Awards Committee shall sign and submit to the Festival a report containing the results and votes (which are not made public by the Festival) for the awards and honors, the names of the members who participated. The original minutes remain in the Secretariat of the Festival.

g) Any change in award or distinction after the dissolution of the meeting is not possible.

The following prizes shall be attributed in the 30th International Competition and will be accompanied by a monetary award, provided that sponsorships are secured:

Best Production Award "TV5 MONDE" is awarded to the Producer. The rest of awards are awarded to the director. It is expressly provided that awards may not be shared.

Drama International Short Film Festival is qualified by the American Academy of Motion Picture Arts and Sciences. Recipients of the festival's Grand Prix will be eligible for consideration in the Short Films competition of the Academy Awards® without the standard theatrical run, provided the film otherwise complies with the Academy rules. (Oscar® qualified)

The Drama International Short Film Festival, as a member of the Short Film Programme of the European Film Academy, is eligible to submit one film for consideration in the awards of the Academy. This submission is contingent upon the film's adherence to the EFA rules.

# 3. International Student Competition

# **General Principles**

- A. The International Student Competition of the Drama Short Film Festival will take place from September 2nd to 8th, 2024.
- B. To be eligible for participation, films shall meet the following conditions:

B.a. Greek Premiere is required for the submission of films to the Competition. Therefore, prior public performance, screening, broadcasting or rebroadcasting of the works to the public by radio and television by any means to the public in Greece or on-demand access in any way before or during the days of the Festival are not allowed. The presentation of the film shall be deemed to be public when the film becomes accessible to a circle of persons wider than the narrow circle of the family and the immediate social circle of the author, regardless of whether the persons of this wider circle are at the same or at different locations.

B.b. Films shall be completed within the year 2023 or 2024.

B.c. The DCP to be screened at the Festival shall be available in one of the formats provided for in this Regulation for film screening and in one of the formats provided for in this Regulation for online screening.

B.e. Each director may participate in the Festival with only one (1) film, and shall declare the type of film (documentary, fiction, animation),

B.f. The Preliminary Committee may, in its sole discretion, approve one or more films submitted to the Present Competition Program, for further participation in other Programs in accordance with the provisions of this Regulation and in particular for the International Competition Short & Green, International Animation Competition Programme and for the Program — Cinematherapy Lab provided that these films meet the general principles of this and the corresponding Competition program and after the consent of the candidates has been obtained

B.g. Film genres that may participate: fiction films, documentary films, animated films, experimental films.

B.h. Films that have participated and were rejected by the Preliminary Committee may not be submitted.

# 3.1. Deadline for application – Application fee

a. The application form and a digital copy of the film shall be submitted through the website www.filmfreeway.com by May 8, 2024 electronically. Following a

- relevant announcement, it is possible for submission to be made possible through other platforms.
- b. For submissions up to the 30<sup>th</sup> of April, application fee amounts to eight (8) euros per film submitted, and for submissions from the 1<sup>st</sup> until the 8<sup>th</sup> of May application fee amounts to ten (10) euros. Payment is due with submission. Once the digital submission is finalized, fees may not be refunded. In addition, the festival reserves the right to provide discounted or total waver codes to film or educational institutions or directors unable to pay the submission fees. Waivers are provided upon their request before the Independent Department of the Drama Short Film Festival, and relevant Administration's decision.

# 3.2. Application: Entry Procedure and Material

The director or producer must submit by May 8, 2024 to the filmfreeway platform a non-public link of the film for the pre-selection (secure/password protected downloadable link, which should be available until the announcement of the programme)

In case of selection the following should also be submitted:

- a. The application completed in all required fields.
- b. The declaration license and guarantees of the author and / or producer of and / or rightholder over the film, as provided in Annex I hereof, signed.
- c. A non-public link of the film for the preliminary committee (a downloadable secure / password protected link, available until the announcement of the results of the preliminary committee).
- c. If the original language of the film is not Greek, a list of dialogues of the film in Greek must also be submitted. Otherwise, the film must be subtitled in Greek.
- d. At least one (1) photograph of the film and one (1) of the director.
- e. A poster of the film in A4 format

The files submitted with the application form remain in the Festival Archive, as defined in term V hereof. When submitting the application, the producer declares whether he wishes the inclusion of the film in the Film Market, as defined in term VI hereof and in accordance with the specific terms to be notified to the applicants.

# 3.3. Preliminary Committee

a. Films are selected for the competition by a three (3) to seven (7) members Preliminary Committee and the head of the Preliminary Committee who oversees their work. All members of the Committee shall be experts from the audiovisual sector. The Preliminary Committee shall be appointed by the Board

- of the Cultural Organization upon the Artistic Director's or, (if he is prevented), his Deputy's proposal.
- b. Once the films for the competition are selected, applicants shall be informed, by any appropriate means, about the decision of the Committee. Applicants shall not disclose the decision and not make any relevant statement and/or publication on media, including social media until the official public announcement of the Festival.
- c. Films that have not been selected for the competition do not participate during the screening days of the Festival, but are included in the Film Market, as further defined in term VI hereof, provided that the applicant has provided a relevant license at his application.
- d. The Preliminary Committee may, in its sole discretion, approve one or more films submitted to the Present Competition Program, for further participation in other Programs in accordance with the provisions of this Regulation and in particular for the International Competition Short & Green, International Animation Competition Programme and and for the Program Cinematherapy Lab provided that these films meet the general principles of this and the corresponding Competition program and after the consent of the candidates has been obtained.

- a) Digital Cinema Package (DCP) in one of the following acceptable formats:
- -DCP subtitled in English or Greek for films in a language different than Greek.
- -Apple ProRes, subtitled in English or Greek for films in a language different than Greek.
- -H264 subtitled in English or Greek for films in a language different than Greek.
- -MPEG4, subtitled in English or Greek for films in a language different than Greek.
- b) For the online screening on the platform of the Festival are additionally required:
- -One (1) mp4 file of the final version of the film, subtitled in English or Greek for films in a language different than Greek, for the Film Market, as further defined in term VI hereof.

c) Signed statements of final technical check by the technical manager of the film and the director.

- g) Any change in award or distinction after the dissolution of the meeting is not possible.

The following awards shall be attributed in the International Student Competition and will be accompanied by a monetary award, provided that sponsorships are secured:

- GRAND PRIX STUDENT "ALMOST FAMOUS"
- SPECIAL JURY AWARD "RISING STAR"
- QUEER STUDENT AWARD: "Loud & Proud"

It is expressly provided that awards may not be shared.

# 4. "Short & Green" Competition

# **General Principles**

- A. The International Environmental "Short & Green" Competition of the Drama Short Film Festival will take place from September 2nd to 8th, 2024.
- B. To be eligible for participation, films shall meet the following conditions:
- B.a. Greek Premiere is required for the submission of films to the Competition. Therefore, prior public performance, screening, broadcasting or rebroadcasting of the works to the public by radio and television by any means to the public in Greece or on-demand access in any way before or during the days of the Festival are not allowed. The presentation of the film shall be deemed to be public when the film becomes accessible to a circle of persons wider than the narrow circle of the family and the immediate social circle of the author, regardless of whether the persons of this wider circle are at the same or at different locations.
- B.b. Films shall be completed within the year 2023 or 2024.
- B.c. The DCP to be screened at the Festival shall be available in one of the formats provided for in this Regulation for film screening and in one of the formats provided for in this Regulation for online screening.
- B.e. Each director may participate in the Festival with only one (1) film, and shall declare the type of film (documentary, fiction, animation),
- B.f. Film genres that may participate: fiction films, documentary films, animated films, experimental films concerning environmental issues, nature and the environment.
- B.g. Films that have participated and were rejected by the Preliminary Committee may not be submitted.

# 4.1. Deadline for application - Application Fee

The application form and a digital copy of the film shall be submitted through the website www.filmfreeway.com by May 8th, 2024 electronically. Submission through other platforms may also be announced.

For submissions up to the 30<sup>th</sup> of April, application fee amounts to ten (10) euros per film submitted, and for submissions from the 1<sup>st</sup> until the 8<sup>th</sup> of May application fee amounts to twelve (12) euros. Payment is due with submission. Once the digital submission is finalized, fees may not be refunded. In addition, the festival reserves the

right to provide discounted or total waver codes to film or educational institutions or directors unable to pay the submission fees. Waivers are provided upon their request before the Independent Department of the Drama Short Film Festival, and relevant Administration's decision.

- 1. In case of selection the following should also be submitted:

B.d. Each director may participate in the Festival with only one (1) film, and shall declare the type of film (documentary, fiction, animation),

B.e. Film genres that may participate: animated films.

B.g. Films that have participated and were rejected by the Preliminary Committee may not be submitted.

B.d. No restriction shall apply regarding the number of films to be submitted by each film school. Each director may participate in the Festival with only one (1) film.

B.e. Film genres that may participate: fiction films, documentary films, animated films, experimental films.

B.f. The Preliminary Committee may, in its sole discretion, approve one or more films submitted to the present Competition Program, for further participation in other Programs in accordance with the provisions of this Regulation and in particular for the International Competition Short & Green, International Animation Competition Programme and for the Program — Cinematherapy Lab provided that these films meet the general principles of this and the corresponding Competition program and after the consent of the candidates has been obtained

B.g. Films that have participated and were rejected by the Preliminary Committee may not be submitted.

The presentation of the film shall be deemed to be public when the film becomes accessible to a circle of persons wider than the narrow circle of the family and the immediate social circle of the author, regardless of whether the persons of this wider circle are at the same or at different locations.

- B.b. Films shall be completed within the year 2023 or 2024.

Films are selected for competition by the Chair of the Program, appointed by the Board of the Cultural Organization upon the Artistic Director's or, (if he is prevented), his Deputy's proposal.

#### 8.3 Distinctions

Within the framework of the Cinematherapy Program, it is possible, following the decision of the Festival, selected films to be distinguished. Specific issues for these Awards will be announced within a reasonable period of time.

# 9. Educational Program Drama Pitching Lab

# **General Principles**

- A. The Cultural Organisation may organize in Drama, from the 2th to 8th September, 2024, the Educational Program Drama Pitching Lab for Developing ideas for short films, during the Drama Short Film Festival. Following the announcement of a relevant call on the website of the Festival, ten (10) to fourteen (14) projects submitted for participation are selected.
- B. To be eligible for participation in the Educational Program Drama Pitching Lab, the drafts shall meet the following conditions:

- B.a. Submission dossier shall meet the conditions to be announced by the educational tram.
- B.b. Each director has the right to participate with one (1) project.
- B.c. Film genres that may participate: fiction films, documentary films, animated films.
- B.d. Projects that have participated and been rejected by the Preliminary Committee may not be submitted.

# 9.1. Deadline for application

The complete dossier with the prerequisites set by the educational team shall be submitted via email to pitching@dramafilmfestival.gr by **April 25th, 2024.** 

# III. "Drama Festival Travels"

The Festival organizes the screening of films in various regions of Greece, seeking to promote the filmmakers and their work.

In particular, in collaboration with cultural institutions, public organizations and legal entities under public and private law, the Festival promotes the screening in appropriate venues in Athens (a) of all films that will be submitted for participation in the Official Greek Competition Program and (b) the films that will be submitted for participation in the International Competition Program and will be awarded.

Furthermore, and for a period of fourteen months, i.e., from October 2024 to December 2025, the films that will be awarded in each category may be selected for screening by a network collaborating with the Festival (such as Cinema Clubs, Municipal Cinemas, Festivals, Cultural Organizations, Municipalities, Cultural Centers, Associations and Extraordinary Events).

The Cultural Organization will obtain a relevant written permission from the producer or his heirs for the participation of the films in this action.

## IV. Pre-Festival and Other Events

The Festival may at its sole discretion support pre-festival events that will take place before the annual events during September and from March to the end of July. Parties that need support may address their proposals including the subject, the content, the duration and the budget of such events, as well as a request towards the Organisation for the amount and type of support until the 7<sup>th</sup> April 2024. Such requests shall be reviewed by the Organisation.

Furthermore, the Festival may during the year organize educational programs and other events curated by the Artistic Director, in cooperation with Public or Private Entities.

# V. Copyright

The author and / or producer and / or rightsholder (hereinafter referred to as "Producer") declare that they hold all the copyrights required for the film to be submitted and to participate in the competition programs and the events of the Festival. The Producer shall submit, when applying, the relevant statement - provision of guarantees in printed or digital form, as provided in Annex I hereof, providing the necessary licenses.

It is possible that films submitted for participation in Competitive Programs according to the present Regulation will be selected for non-competitive events of the Festival, such as events for special occasions and / or events of other organizations - organizers. In case of selection of a film for participation in a non-competitive action, the Cultural Organization will obtain a relevant written permission from the Producer or his heirs.

The Festival is permitted to broadcast snapshots and / or extracts of any work submitted for a duration not exceeding 2'59" by the Media and / or the internet for the promotion of the film and the Festival. The license for the aforementioned retransmission is valid for one (1) year from the final choice of the film.

# VI. Archive

Since its establishment, the Cultural Organization - Drama Short Film Festival has always conducted a mission of preservation, collection and classification of any document, work of art, audiovisual material and any other material or audio material of cultural creation. Furthermore, the Cultural Organization proceeds to the recording, indexing, classification and microphotography or digitization of the aforementioned files or media, in order to make them available to the public but also the operation of the departments and programs of the Legal Entity and the Municipality. Furthermore, the Cultural Organization creates, organizes and preserves archives that have a special historical value for the public, so that they can be used for study and research.

To this effect, each participant gives a free permission to the Cultural Organization for the perpetual storage, preservation, archiving and classification of the audiovisual work in the archive of the Cultural Organization. Participants also give a free permission to the Cultural Organization to make a copy of the work in any form, technologically known or not today, in order to ensure its preservation. The participant may revoke the relevant permission.

The Cultural Organization shall request for a permission from the participant/rightsholder, in order to include an audiovisual work in a special archive for study, research and / or other use, promotion or exploitation.

# VII. Film Market

As part of its objectives and in alignment with international practices in the field of audiovisual events, the Cultural Organization operates an online platform known as the Film Market. The primary goal of this platform is to facilitate communication between directors and producers, connecting them with distribution companies and television channels. The overarching purpose is to facilitate the purchase, distribution, and promotion of films not only within the festival but also at other international events. This initiative aims to foster interaction among professionals in the short film industry, thereby promoting their economic activities.

The Film Market encompasses all films submitted for participation in the competition sections of the Festival. Greek films, in particular, are allocated to a distinct category. It is important to note that the Festival reserves the right to categorize films at its discretion, and contributors may not receive prior notification of such categorization.

The file submitted by the applicant shall be uploaded to the Film Market. In case of modification of the file, any interested party can send a request via email to info@dramafilmfestival.gr

In case of objection to the described upload to Film Market, the applicant shall send a request via email to info@dramafilmfestival.gr

## VIII. Receive and Return of materials

Hard drives and other hardware shall be sent in the Secretariat of the Festival, either in Drama or in Athens. Shipping costs for the participation and return of hardware shall be paid by the participants.

# IX. Personal Data

For the participation in the Festival, all personal data required in the application form shall be collected, namely:

- (a) the names of the director, the actors and all the contributors;
- (b) the e-mail address of the applicant;
- (c) a brief curriculum vitae of the director;
- (d) a photograph of the director.

(e) contact details (email address and telephone number) of the producer and director

The Cultural Organization may publish in the Media, on social media, in newspapers (print and digital) and all kinds of websites concerning cinema, in addition to information and data relating to the film, the names of the director, the actors and all the contributors, the c.v. of the director and the photograph of the director.

The Cultural Organization is the controller of personal data and determines the purposes and means of the processing of personal data as defined by the personal data protection policy.

#### X. Miscellaneous

The screening program of films in each Competition Program shall be determined by the Artistic Director of the Festival.

It is underlined that non-compliance with the set deadlines leads to exclusion from the procedure.

It is explicitly noted that all the dates and deadlines provided in this Regulation, including those mentioned for each competition program are indicative for the Festival, which reserves the right to modify them. In case of any change, the Festival shall notify the public and all interested parties.

The Awards for each Program may be modified and / or changed upon the recommendation of the Artistic Director.

It is explicitly noted that in case of force majeure, the Festival may be canceled or conducted only in digital form. General strike, natural disasters and emergency measures for the pandemic constitute cases of force.

The President of the Festival is responsible for resolving any dispute that may arise as a result and during the implementation of this Regulation and makes every effort in order amicably settle any dispute in accordance with the principles of good faith.

In case of non-settlement, the dispute shall be subject to the mediation process, conducted by a mediator registered in the Register of Certified Mediators maintained by the Ministry of Justice, Transparency and Human Rights. The seat of mediation will be Drama, in Greece, and the process will be conducted in Greek.

If the dispute is not settled through mediation within twenty (20) days from the beginning of the procedure, the Courts of Drama are solely responsible for the final settlement of the dispute arising from the application of this Regulation and the applicable law is Greek law.
